The new mobile board increased visibility and availability. Plus, using it with other large buffer vehicles has increased safety. It's helped enough that the city is planning on building another.

DID YOU KNOW?

SOCIAL SECURITY FAIRNESS ACT CHANGES & THE WISCONSIN RETIREMENT SYSTEM

The recently signed Social Security Fairness Act marks a significant milestone in retirement benefits for public sector employees. This landmark legislation, signed into law by President Biden on January 5, 2025, eliminates the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). These provisions previously reduced Social Security benefits for individuals receiving public pensions from work not covered by Social Security. With the repeal of WEP and GPO, nearly three million public pensioners, including municipal employees, will now have full access to their earned Social Security benefits.

In Wisconsin, the impact of the Social Security Fairness Act can be significant for municipal employees participating in the Wisconsin Retirement System (WRS). Wisconsin's municipal employees will now receive their full Social Security benefits. No action is needed from employers. It is recommended that Social Security Beneficiaries update their contact information.
