The City of River Falls Fire Department has been working hard to minimize the risk of responding to electrical vehicles (EVs). EVs are particularly dangerous because they run quiet, which makes it hard to determine if they are on. EVs can cause electrocution, and if the battery pack catches fire, they can experience thermal runaway.

The City of River Falls has invested in the Emergency Plug and Reusable Car Fire Blanket Pro-X. The plug communicates with the car to keep it from moving and the blanket reduces flame, smoke, and prevents fire.
